### Stop Notario Fraud

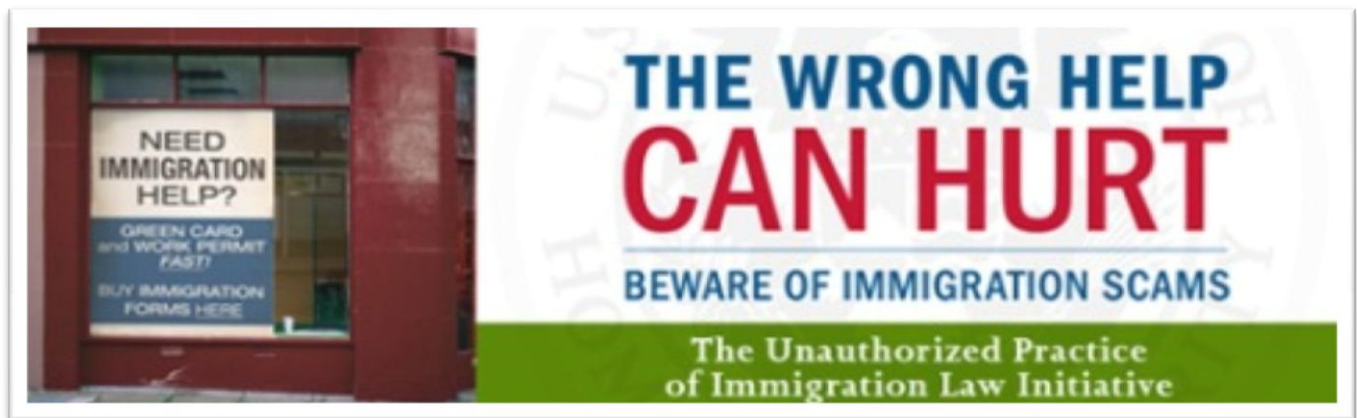
Only licensed attorneys and those working with organizations accredited by the Board of Immigration Appeals are authorized to provide legal advice or represent someone before an immigration agency. However, unscrupulous individuals who are not authorized to provide legal assistance often promise immigrants legal help, sometimes charging large sums of money.

**Immigration laws and regulations are complex and challenging – don't trust your status to a "notario."**
