What ideas do you have for continuing to build relationships with the schools?

- Collaborating with families and schools at the beginning of the year
- Continuing truancy meetings at the FRC
- Putting out surveys to the schools (through the superintendent)
- Help schools on their terms
- DBT skills classes to school adjustment counselors
- Referral letter from the school after student is truant
- Cultural training in schools
- Equity coalition meetings at night
- Offering workshops with schools for families

- Continue outreach
- Trying to find out how FRC can service schools (e.g. trainings, transportation, space)
- Transporting clients to school appointments, meetings, open houses
- Attend community partnership meetings
- Continued connection with school personnel during summer and transitional times
- Communication with McKinney Vento contact people
- Contact and collaborate with City Connects
- Re-educating providers
- Get to know the school adjustment counselors/attendance officers and build a relationship
- Follow up emails, start/mid/end of year emails
- Better hours for part time School Liaisons
- Regular meetings with administration, special education, and superintendent*
- Curriculum provided by FRC to families regarding CRA
- Become part of the schools' policies*
- Have lunch with a school contact (purposeful networking)
- Utilize peer mentors to address school refusal
- Be proactive about understanding the mental health component of school refusal and educating schools and families

Next Steps:

- School Liaison Cohort Meetings will be held quarterly moving forward
- DCF encourages FRC staff to use FRConnect discussion boards for maintaining connections between School Liaison Cohort Meetings and add a photo to their profile page
- DCF will look into the possibility of mentor/mentee relationships for School Liaisons who are interested in partnering for support
- School Liaisons are encouraged to attend upcoming Regional PMPD meetings that include ESSA training with FRC management in Western Ma and possibly in other regions
- DCF is prioritizing training needs for School Liaisons based on feedback from the group. Currently, the most requested trainings include:
 - Special Education/Basic Rights/IEPs
 - Attendance/School Refusal
 - Transition Age Youth
 - School Discipline
 - Placement Options
 - CRA Law and Process
 - o School/Special Education Evaluations and Assessments
- DCF will be sending out a School Liaison contact list so the group can contact each other with questions, concerns, and support
- DCF will be sharing contact info for our team member Elaine Arsenault, from the Federation for Children with Special Needs

• School Liaisons are asked to submit educational/law resources to Kate Darmetko, who will compile a list and share with the group
